News and Updates

Merging Committee Report - July 2022

7/11/22 Meeting

For our very first meeting as a merging committee, we opened with prayer for guidance and wisdom. We also created a Covenant that we would commit to following throughout this process, and wrote it on a poster board so that we can view it each meeting. This Covenant included the following promises to one another:

- Respect one another
- Honor and appreciate the traditions of both churches
- Being open and willing to change the things we need to change
- Commitment to listening fully to one another
- Being willing to ask questions and to communicate fully
- Promising confidentiality and committing to trust
- Doing our due diligence in decision making
- Committing to work and responsibility outside of our meeting times
- Keeping God at the front and center of all we do

Each member signed this Covenant as a further signal of our commitment to it.

We also created a list of things we felt the committee would need to complete as a group. This list is flexible and can be added to. Currently, it includes:

- Choosing a soft launch date when the two congregations start worshiping together every week (we decided on 8/7/22)
- Choosing a hard launch date when we introduce ourselves to the wider community and invite them to join us (we decided on 1/8/23)
- New name
- Creating a new employee identification number with the IRS
- Storage unit/merging furniture and supplies
- Creating a budget
- Creating new bank accounts and merging finances
- Updating employee and staff contracts to reflect new employer
- Mission, vision, and values
- New constitution and bylaws
- Worship structure
- New committee structure (board, council, elders, deacons, etc.)
- Updating website, logo, brand, etc.
- Identifying outreach and mission priorities

We agreed to prioritize our worship structure (what things will be included when we start officially worshiping together in August) and the budget. We felt it was important to prioritize the budget because it will help guide any additional financial conversations that we have and give the congregation a full picture of how we will be moving forward financially. Each member will think about financial needs for the church and look over each church's budget and balance sheets in preparation for our next meeting.

7/25/22 Meeting

We once again opened our meeting with a time of prayer as part of our commitment to centering God and faith in our discussions. We started by reaffirming our decision making hierarchy moving forward, as a means of clarifying who makes what decisions. The hierarchy is:

- Congregation the combined congregation of both churches have the ultimate authority and final say on all major decisions
- Merging committee will discuss major decisions before bringing suggestions to the congregation for approval. All decisions related to the new church will go through the merging committee first.
- Mt. Healthy board and St. Paul Council Will remain responsible for day-to-day decisions that keep the churches operating (i.e. building usage, communion prep, managing current financials/budgets, etc.). Monthly meetings won't be necessary/required unless something specific needs to be discussed that doesn't fall under the responsibility of the merging committee.
- Individuals each person within both congregations are always welcome to make suggestions or ask questions

We then talked about what worship will look like moving forward. Every member was provided with examples of each congregation's order of worship, and we talked through things we want to keep, things we can remove, and the order of the service. This included discussions around long-term hopes for worship, such as a choir, children's moment, etc. Pastor Brian will put together a new order of service based on the committee's feedback, and will bring it back to our next committee meeting for approval. It was also agreed upon that our worship bulletin will be a flexible document, open to suggestions and changes as the new church becomes more fully formed.

We also discussed the storage unit and our desire to quickly decide what to do with the remaining furniture and items. A sub-committee was formed (Ben, Mike, Steve, Judith) to visit the storage unit on 7/28/22 to finalize which items will be brought to the church, which will be donated/sold, and to create a timeframe for closing out the storage unit.

Our final conversation revolved around the budget. Steve and Deb offered insight and clarification into the various pieces of both church's budgets. We also discussed potential long term costs/hopes (replacing the air conditioning, building maintenance, church van, etc.) and their potential impact on the budget. Pastor Brian agreed to attempt to merge the budgets for our next meeting, with additional assistance from Deb, Steve, and Anne (St. Paul's treasurer), and bring the budget back at our next meeting for further review and discussion.

Our next meeting in August will focus on finalizing a worship bulletin, clarifying and finalizing a budget, and beginning the process of soliciting ideas for the name of the new church. We will also hear a report back from the sub-committee on a proposal around the storage unit.
